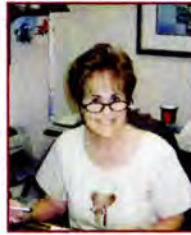


About the Owner

Service Selections

Delivered in the privacy of your own home.

Companions - a helping hand with laundry, meal preparation, bed making, grocery shopping, light housekeeping and providing transportation to medical appointments.
4 hour minimum **\$16.50 per hour**

Personal Care Attendant - personal care in the areas of bathing, dressing, grooming and hair care, medication reminders, ambulatory assistance, plus limited companion duties. **4 hour minimum** **\$17.75 per hour**

Certified Nurse Aides - certified to assist with self-administered medications, doctor prescribed exercises, total hands-on-care bathing, simple incontinence and toileting issues, non-sterile dressings and performs limited companion duties. The CNA follows a medically supervised plan of care established by the doctor, RN or pharmacist.

Live-In Care - The three above levels of care are available on a twenty-four hour live-in basis, when appropriate. Please call for details.

Beginning at \$260.00 Daily

Transportation - Pickup and delivery to medical appointments, shopping, banking, hair salons, and other miscellaneous visits. No companion or personal care services performed. **2 hour minimum**

\$16.50 per hour plus mileage charge

Hourly Care Under 4 Hours - We can provide shorter hours when caregivers are available, however there will be an additional charge of **\$2.50 per hour** for those services.

Payment Methods - All services are private pay. We do accept MasterCard and Visa for payment. If you have a long term care policy that pays for home health care, a portion of your services may be covered. Please let us know and we will make those inquiries for you.

Medicare does not cover any personal care/custodial care expenses.

No Charge for the RN Assessment Visit

Holidays charged at time and one half. From 7 PM New Year's Eve, New Year's Day, Easter, Memorial Day, July 4th, Labor Day, Thanksgiving, from 7 PM Christmas Eve and Christmas Day.
